7. Conclusion

The Loss Costs of IIBI represent pure losses and ALAE only. They should be loaded for CAT losses, ULAE, expenses, commissions, profit margin or other loadings to arrive at the final price to be charged in accordance with IRDAI's Circular No. IRDA/NL/MISC/246/11/2014 dt.12.11.2014 directing all Indian non life insurers on the adoption of Burning Costs by the industry, providing the Guidelines on Pricing of Risk.

These are referral rates only based on experience for Fire (SFSP) product as per the data submitted by Insurers to IIBI.
